# Boston Region Metropolitan Planning Organization's Transportation Planning Process hosted by Federal Highway Administration and Federal Transit Administration

You are invited to participate in a public meeting about the evaluation of the transportation planning process of the Boston Region Metropolitan Planning Organization (MPO). The Boston Region MPO provides transportation planning services to 97 cities and towns, covering approximately 1,360 square miles and stretching from Boston to Ipswich in the north, Marshfield in the south, and to approximately Interstate 495 in the west. The region is home to nearly three million people and supports about two million jobs.

Every four years, the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) are required by law to review the metropolitan transportation planning process conducted by the Boston Region MPO and its partners in order to certify that they are carrying out the process in accordance with all applicable Federal requirements.

As part of this review, the FHWA and FTA would like to hear from members of the public regarding their views of how the metropolitan transportation planning process is conducted in the Boston region. The Federal agencies are particularly interested in hearing from people who have participated in the planning process conducted by the Boston Region MPO.

This public meeting will be conducted by the FHWA and FTA.

The MPO complies with Title VI of the Civil Rights Act of 1964, the Americans with Disabilities Act (ADA) and other federal and state nondiscrimination statutes and regulations in all programs and activities. The MPO does not discriminate based on race, color, national origin (including limited English proficiency), religion, creed, gender, ancestry, ethnicity, disability, age, sex, sexual orientation, gender identity or expression, veteran's status (including Vietnam-era veterans), or background. Any person who believes herself/himself or any specific class of persons to have been subjected to discrimination prohibited by Title VI, ADA, or another nondiscrimination statute or regulation may, herself/himself or via a representative, file a written complaint with the MPO. Complaints filed under federal law (based on race, color, national origin [including limited English proficiency], sex, age, or disability) must be filed no later than 180 calendar days after the date the person believes the discrimination occurred. Complaints filed under Massachusetts General Law (based on race, color, religious creed, national origin, sex, sexual orientation, disability, or ancestry) or Governor's Executive Order 526, section 4 (based on race, color, age, gender, ethnicity, sexual orientation, gender identity or expression, religion, creed, ancestry, national origin, disability, veteran's status [including Vietnam-era veterans], or background) must be filed no later than 300 calendar days after the date the person believes the discrimination occurred.
